

BACP Grants 2023 demographics report

Following the conclusion of the application process for BACP research grants 2023, this report contains the demographic information relating to the principal investigator (PI) for applications received. Anonymised data has been used to prepare this report in line with our commitment to Equality, Diversity and Inclusion (EDI).

Demographic information is presented for the 31 applications received. For further detail on the demographics specific to each grant type (collaborative, secondary data analysis), please see Appendix A.

Demographic information for all grant applications received

Demographic information was completed by 32 applicants as co-PIs were included in 1 application. 1 applicant selected 'prefer not to say' for all demographic questions.

Applicants were included in all age ranges from 25 to 74 years, with a relatively even distribution across ages ranging from 25 to 64 years. 2 applicants were aged 65+. Approximately two-thirds were female and one-third male with 21 applicants identifying as a woman, 9 as a man and 1 non-binary. Regarding sexual orientation, the majority of applicants indicated heterosexual/straight with 3 gay men and 1 gay woman. When asked their ethnic group, results show that applicants were mainly White, 1 Arab and 1 mixed or multiple ethnic groups. 3 applicants considered themselves to be disabled, each indicating that psychological (mental health) was the barrier they encountered. Approximately half of applicants were married or in a registered civil partnership, 7 partnered and 5 single (2 applicants preferred not to say). 3 applicants were currently/recently (in the last 18 months) pregnant or on parental/adoption leave.
